"AN ORDINANCE CREATING SITIO BALUNGAGAN
OF BARANGAY LINGAYAO, INTO A REGULAR
BARANGAY OF THE MUNICIPALITY OF LAS
NIEVES, AGUSAN DEL NORTE."

Be it ordained by the Sangguniang Panlalawigan
of Agusan del Norte, in session assembled, that:

Section 1. Sitio Balungagan of Barangay Lingayao,
Agusan del Norte, is hereby detached and separated
from its mother barangay to form and constitute into
distinct and independent barangay which is hereby
created to be known as Barangay Balungagan without
affecting in any manner the legal existence of Barangay
Lingayao, the mother barangay;

Section 2. Except as hereinafter provided, all
provisions of law, now or hereafter applicable to
regular barangay shall be applicable to the new barangay
of Balungagan;

Section 3. The territorial jurisdiction of Barangay
Balungagan is hereby defined as follows:

"Beginning at a point "1" plan is due west 5,000 meters from MBM #1, Thence due south with a distance of 1,0430 meters to point 3; Thence due west with a distance of 500 meters to point 4; Thence due south with a distance of 1,100 meters to point 5; Thence due east with a distance of 4,520 meters to point 6; Thence due north with a distance of 2,480 meters to point 1, the point of beginning."

Section 4. The present elected officials of Barangay Balungagan shall continue to perform their duties as officials in the newly created Barangay Balungagan until the new officials of said barangay shall have been appointed by the Municipal Mayor. Such officials so appointed shall hold until their successors shall have been elected and qualified in the regular elections for barangay officials, unless otherwise provided for by law, order or proclamation;

Section 5. The newly created barangay of Balungagan shall come into legal existence upon approval by the majority of the votes cast in a plebiscite called for the purpose by the Commission on Elections to be held on November 29, 1987.

Section 6. The qualified voters of both from the mother barangay and the newly created barangay shall participate in the plebiscite at the voting center(s) to be determined by Commission on Elections or its duly authorized representative.

Section 7. Upon the effectivity of the creation of the new Barangay Balungagan, the proportionate share of the new barangay in the obligations, funds, assets and other property of the former barangay shall be transferred by the Municipal Mayor to the newly created Barangay upon the recommendation of the Commission on Audit.

Section 8. This ordinance shall take effect upon approval.
