AN ORDINANCE FURTHER AMENDING CHAPTER IV, ARTICLE II, SECTION 159 OF PROVINCIAL ORDINANCE NO. 313-2013, THE UPDATED REVENUE CODE OF THE PROVINCE OF AGUSAN DEL NORTE AS AMENDED BY PROVINCIAL ORDINANCE NO. 377-2015, BY INSERTING THE LEASE RENTAL RATE OF REAL PROPERTIES SITUATED IN THE CITY/MUNICIPALITIES OF THE PROVINCE OF AGUSAN DEL NORTE.

BE ENACTED, by the Sangguniang Panlalawigan of Agusan del Norte, in session duly assembled that:

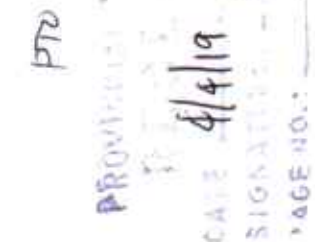
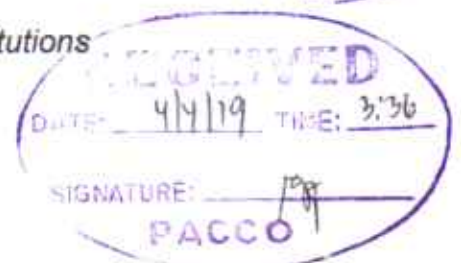
SECTION 1. AMENDMENT. – Chapter IV, Article II, Section 159 (Fees and Charges) of Provincial Ordinance No. 313-2013 that reads as follows:

E. Rental Rate of space within the Capitol Ground/Business Park

₱100.00/sq. meter - Area located along the main road access the Capitol Drive and Capitol Avenue

₱75.00/sq. meter - Area in the interior of the Capitol

₱30.00/sq. meter - For government agencies/institutions

ACTION TAKEN: The committee conducted a meeting on January 16, 2019 with the presence of the above-mentioned attendees to review the above subject matter.

FINDINGS AND RECOMMENDATION:

At the onset of the meeting, the chairman asked Mr. Alan Q. Rafil, PDO IV on the necessity and importance of the proposal. Mr. Rafil opined that the discounted rental rate of the Provincial Training Center should be terminated. According to him, the income received from the lease of the PTC shall be of great help to the office since the province has no longer allotted a budget for them. In the same manner, Mrs. Paulina Batucan added that the Provincial Economic Enterprise Development Management Office or PEEDMO has long been operating independently. All expenses relative to the operation of the office are all taken from the income generated from lease rentals of the property of the province. Further, the salaries and other benefits of the staff were also taken and dependent of the income. Thus, it so reasonable that the long time fifty percent (50%) discount rate granted to clients like LGUs, national agencies should be terminated and the actual lease rate in the upgraded Agusan del Norte Revenue Code shall be collected except only when the activity held is in partnership with the provincial government.

On the other hand, the committee suggested that the proposed elimination of the 50% discount rental rate to those mentioned agencies if it is possible be adjusted to twenty percent (20%) discount rental rate.

It was also discussed that the rental rate for the real properties owned, acquired and purchased by the Province be increased to One Hundred Fifty per square meter (₱150.00/ sq. m) for those property situated in the Butuan City and One Hundred Pesos only per square meter (₱100.00/ sq. m.) for those property situated in various municipalities.

After a thorough discussion, the committee finds that PEEDMO is a separate and distinct office of the Province of Agusan del Norte and has the responsibility to develop, manage and implement local business enterprises and income-generating projects as an economic enterprise. It has the duty and responsibility to improve the financial and economic conditions of the provincial government. The same learned that the 50% discount is only granted to all offices of the provincial government who will use the training center as per Provincial Ordinance No. 270-2010 there was no provision in said ordinance that grant a discount rate to any Local Government Units and National Agencies.

Notwithstanding, the committee recommends the following:

1. To change the discount rental rate from 50% to 20% by amending Provincial Ordinance No. 270-2010 and
2. To increase the rate for the lease of the real properties owned by the provincial governments, to wit:
 - 2.1 Real properties situated within Butuan City shall be ₱150.00 per sq. m.
 - 2.2 Real properties situated in various municipalities shall be ₱100.00 per sq. m.
3. To pass an amendatory ordinance of the Revenue Code under Provincial Ordinance No. 270-210 to stipulate the cited amendments.



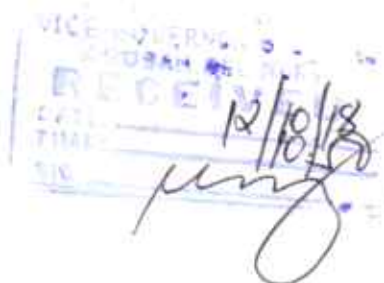

Good day to you Honorable Provincial Governor.

In line with our income generation tasks and local economic enterprise development program engaged by PEEDMO, it has been found out that some provisions covered under our Agusan del Norte Revenue Code are detrimental specially on PS & MOOE reflected in DBM Circular Nos. 100 and 100A.

We would like to request that by CY 2019, rental of facilities in our PTC, PIPC and CCC shall if possible be ruled upon to be increased to 100% payment and not anymore on the original discounted rate of only 50% for all local, national government agencies and other private institutions based on the approved lease rate in our upgraded Agusan del Norte Revenue Code.

Furthermore, in our real properties owned, acquired, purchased by the Province, the rental rate if possible shall be ₱ 150.00/sq.m. specially in Butuan City areas but in various municipalities if possible shall be ₱ 100/sq.m.


Income generating projects (IGP's) shall be given priority allocation of 20% Development Fund and in our non-office appropriation funds starting this year CY 2019 and 50 years thereafter.

If possible all provincial properties located in all areas owned acquired and purchased by the Province of Aguan del Norte shall not be given for free or donated but if possible rented for local economic enterprise purposes allowing it to become productive and generate income.

It is requested that all recommendation will all be considered in our upgraded Revenue Code effective CY 2019.


