**WHEREAS**, the Local Government Code of 1991 provides that the "Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, and appropriate funds for the general welfare of the province and its inhabitants";

**WHEREAS**, being given the task to review and evaluate the monetary matters of the province, the Committee on Finance and Appropriation, during its deliberation and evaluation of the CY 2007 Annual Budget of the Province of Agusan del Norte, considered the request of the Provincial Economic Enterprise Development and Management Office (PEEDMO) to fund the position of Administrative Officer III, Salary Grade 18 at the rate of P190,092.00 per annum;

**WHEREAS**, the committee also observed that the position of Administrative Officer III of PEEDMO is vacant for the past several years and is presently performed by its Supply Officer II, a staff of the administrative Division;

**WHEREAS**, per manifestation of the Provincial Economic Enterprise Development and Management Officer, the said position is necessary for the operations of their office compared to the position of Planning Officer II;

**WHEREAS**, in view of the above said premises and considering its necessity, the committee resolved to abolish the position of Planning Officer II, Salary Grade 15 with an allocation of P180,576.00 per annum, which has been left vacant for the past year, to accommodate the financial requirements of an Administrative Officer III of the Provincial Economic Enterprise Development and Management Office (PEEDMO).

**SECTION 1. TITLE** – This ordinance shall be known as "*An Ordinance Abolishing the Position of Planning Officer II, Salary Grade 15 of the Provincial Economic Enterprise and Management Office (PEEDMO), this province*".

**SECTION 3. EFFECTIVITY** – This ordinance shall take effect upon approval.


