ORDINANCE AMENDING SECTION OF "AN PROVINCIAL ORDINANCE NO. *144-2003* ORDINANCE CREATING THE POSITION OF THE PROVINCIAL COOPERATIVES OFFICER UNDER THE OFFICE OF THE PROVINCIAL GOVERNOR. BY CHANGING POSITION THE TITLE OF THE PROVINCIAL COOPERATIVES OFFICER ТО SUPERVISING COOPERATIVES DEVELOPMENT SPECIALIST

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE: This ordinance shall be known as "An Ordinance Creating the Position of the Provincial Cooperatives Officer Under the Office of the Provincial Governor, by Changing the Position Title of the Provincial Cooperatives Officer to Supervising Cooperatives Development Specialist".

SECTION 2. AMENDMENT: Section 1 of Ordinance No. 144-2003, which reads:
