AN ORDINANCE AMENDING SECTION 1 OF  
 PROVINCIAL ORDINANCE NO. 144-2003 "AN  
 ORDINANCE CREATING THE POSITION OF THE  
 PROVINCIAL COOPERATIVES OFFICER UNDER THE  
 OFFICE OF THE PROVINCIAL GOVERNOR, BY  
 CHANGING THE POSITION TITLE OF THE  
 PROVINCIAL COOPERATIVES OFFICER TO  
 SUPERVISING COOPERATIVES DEVELOPMENT  
 SPECIALIST

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

**SECTION 1. TITLE:** This ordinance shall be known as "An Ordinance Creating the Position of the Provincial Cooperatives Officer Under the Office of the Provincial Governor, by Changing the Position Title of the Provincial Cooperatives Officer to Supervising Cooperatives Development Specialist".

**SECTION 2. AMENDMENT:** Section 1 of Ordinance No. 144-2003, which reads:

"SECTION 1. CREATION - A Position of Provincial Cooperatives Officer is hereby created, a Division Head under the Office of the Provincial Governor".

To be amended and to read as follows:

"SECTION 1. CREATION - The Position of a Supervising Cooperatives Development Specialist is hereby created, a Division Head under the Office of the Provincial Governor".

All other Sections including the title of the Ordinance No. 144-2003 stating the position title of Provincial Cooperatives Officer shall likewise be amended.

**SECTION 3. EFFECTIVITY:** This ordinance shall take effect upon approval.
