PROVINCIAL ORDINANCE NO. 235-2008

**AN ORDINANCE IMPLEMENTING THE PLANTILLA OF POSITIONS ALLOCATION AND APPOINTMENT OF THE DIFFERENT OFFICES OF THE PROVINCIAL GOVERNMENT OF AGUSAN DEL NORTE CONVERTING THE OLD PLANTILLA POSITION TITLES TO ITS NEW CLASSES AS AUTHORIZED UNDER BUDGET CIRCULAR NO. 2004-3 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)**

**SECTION 1. TITLE** - This ordinance shall be known as "An Ordinance Implementing the Plantilla of Position Allocation and Appointment of the Different Offices of the Provincial Government of Agusan del Norte to its New Classes."

**SECTION 2. ALLOCATION AND REALLOCATION OF POSITION TITLES** - In accordance with DBM Budget Circular No. 2004-3A, the Provincial Government of Agusan del Norte hereby implement the Plantilla of Position Titles of the different offices to its new class.

**SECTION 3. CONVERSION OF THE OLD PLANTILLA POSITIONS TO ITS NEW CLASS**- Old plantilla of positions titles in the different offices in the Provincial Government performing staff and non-technical functions are hereby converted to their new position titles per table of position classification by office.

**SECTION 4. EFFECTIVITY** - This Ordinance shall take effect upon approval.




