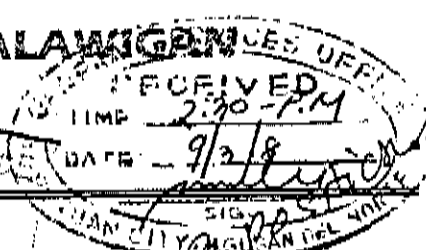

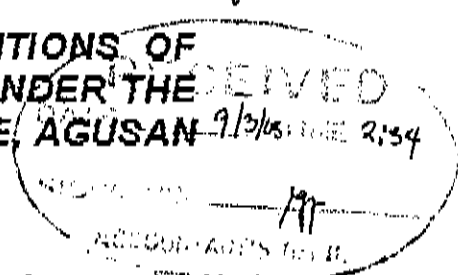

PROVINCIAL ORDINANCE NO. 230-2008

AN ORDINANCE ABOLISHING THE POSITIONS OF SECURITY GUARD III AND WATCHMAN UNDER THE PROVINCIAL GENERAL SERVICES OFFICE, AGUSAN DEL NORTE

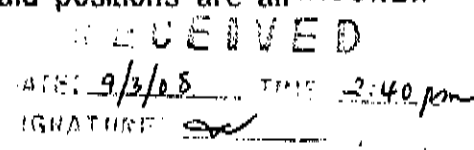


WHEREAS, the Provincial General Services Office, Agusan del Norte, proposes to hire security guards from the private security agencies to enhance more efficiency in the delivery of security services in the capitol premises;

WHEREAS, in realization to the said proposal, two positions are abolished and the funding allocation of the said positions will be reverted to MOOE for the payment of said security services;

WHEREAS, the abolition of the two positions is in order and in line with the intention to out-source security services for efficacy, said positions are affirmed vacant.

NOW, THEREFORE -



BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE: This Ordinance shall be known as an "Ordinance Abolishing the Positions of Security Guards III and Watchman of the Provincial General Services Office".

SECTION 2. ABOLITION OF POSITIONS: There is hereby two positions to be abolished under the Provincial General Services Office of Agusan del Norte, to wit:

SECTION 3. EFFECTIVITY: This ordinance shall take effect upon approval.




