**AN ORDINANCE COLLAPSING TWO POSITIONS OF
CLERK IV AND STORE KEEPER II IN THE
PROVINCIAL ECONOMIC ENTERPRISE
DEVELOPMENT AND MANAGEMENT OFFICE
(PEEDMO), THIS PROVINCE, TO FUND ITS CASHIER
II POSITION**

WHEREAS, the Provincial Economic Enterprise and Management Office (PEEDMO) is proposing to fund the position of Cashier II which is vital and significant in its operations, particularly in the implementation of the Provincial Employees Welfare Support Fund (PEWSP);

WHEREAS, to realize the proposal, two vacant positions of Clerk IV and Store Keeper II, are to be collapsed, to fund Cashier II position.

NOW THEREFORE –

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE: This Ordinance shall be known as an "Ordinance Collapsing Two Positions of Clerk IV and Store Keeper II in the Provincial Economic Enterprise Development and Management Office (PEEDMO), this province, to Fund its Cashier II Position.

SECTION 2. COLLAPSED POSITIONS: The two positions to be collapsed under the Provincial Economic Enterprise Development and Management Office, Agusan del Norte, to fund the position of Cashier II are as follows:






