PROVINCIAL ORDINANCE NO. 248-2009

AN ORDINANCE AMENDING SECTION 3, ITEM 3.10 OF PROVINCIAL ORDINANCE NO. 243-2008, "AN ORDINANCE APPROPRIATING THE SUM OF FOUR HUNDRED THIRTY EIGHT MILLION NINE HUNDRED NINETY SEVEN THOUSAND FIVE HUNDRED EIGHTY (P438,997,584.00) PESOS **FOR** OPERATION MAINTENANCE AND OTHER SUPPORT SERVICES OF THE PROVINCIAL GOVERNMENT OF AGUSAN DEL NORTE AND ELEVEN MILLION THREE HUNDRED TWO THOUSAND **FOUR** HUNDRED SEVENTY FOUR PESOS (P11,302,474.00) FOR THE **ECONOMIC** PROVINCIAL **ENTERPRISE** DEVELOPMENT AND MANAGEMENT OFFICE FOR FISCAL YEAR 2009 AND FOR OTHER PURPOSES"

BE IT ENACTED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE – An Ordinance Amending Section 3, Item 3.10 of Provincial Ordinance No. 243-2008 from the amount of P63,835,746.00 to P63,799,978.00, and with the sub-total from P279,998,736.00 to P279,962,968.00.

SECTION 2. AMENDMENT - Item 3.10 of Section 3 which reads:
