

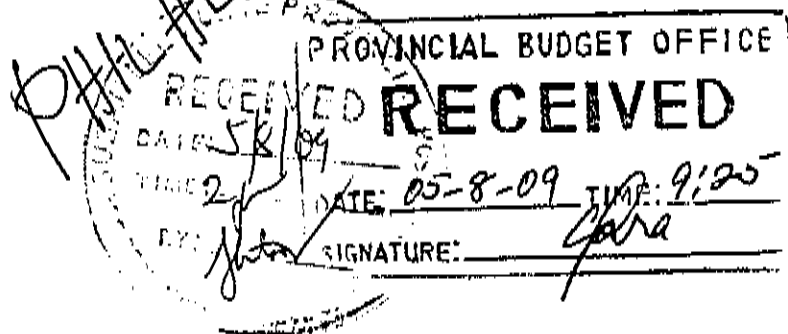

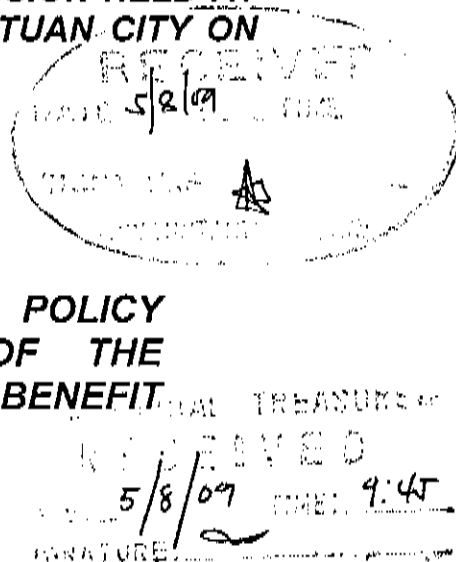

PROVINCIAL ORDINANCE NO. 251-2009

AN ORDINANCE ESTABLISHING A POLICY GUIDELINES FOR THE UTILIZATION OF THE PHILHEALTH TB-DOTS OUTPATIENT BENEFIT PACKAGE REIMBURSEMENT



BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE – This ordinance shall be known as **"An Ordinance Establishing a Policy Guideline for the Utilization of the PhilHealth TB-DOTS Outpatient Benefit Package Reimbursement."**

SECTION 2. OBJECTIVE – This ordinance aims to create a Trust Fund to ensure that the money from the PhilHealth TB-Directly Observed Treatment Short-Course (DOTS) Outpatient Benefit Package Reimbursement shall be utilized solely by the Agusan del Norte Provincial Health Office Public-Private mix DOTS (PPMD) Unit.

SECTION 3. USAGE – The reimbursement from the PhilHealth TB-DOTS Outpatient Benefit Package Reimbursement be used for the operational expenses of the PPMD Unit.

SECTION 4. POLICY GUIDELINE – The following are the policies and guidelines in utilizing the PhilHealth TB-DOTS Outpatient Package reimbursement, to wit:

The Agusan del Norte Provincial Health Office PPMD Unit shall allocate the amount of Four Thousand Pesos (P4,000.00) per member provided by the PhilHealth Outpatient Anti-TB DOTS Benefit Package in the following manner:




