PROVINCIAL ORDINANCE NO. 272-2010 November 8, 2010 Page two –

Further, any person who owns or found to be in possession or stocking of the aforecited items in his house and bodega within his vicinity without the necessary documents mentioned, shall subject the water hose for confiscation and the imposition of penalty as herein provided.

**SECTION 5. MONITORING AND ENFORCEMENT** - All barangay officials are hereby directed to closely monitor the transport and use of water hose within their area of responsibility and the strict enforcement of the provisions of this Ordinance.

Personnel from the Philippine National Police (PNP), the Department of Environment and Natural Resources (DENR) and the Provincial/City/Municipal Environment and Natural Resources Office are hereby authorized to also enforce this Ordinance.

**SECTION 5. PENAL PROVISION** - Any violators of this Ordinance shall be penalized as follows:

- 5.1 Any person found to have violated Paragraphs 2 and 3, Section 4 of this Ordinance shall be imposed a fine in the amount of Two Thousand Pesos (P2,000.00) to Three Thousand Pesos (P3,000.00) and confiscations of all his/her water hoses and/or an imprisonment for a period of six (6) months.
- 5.2 Any person found using or practicing placer mining method in violation of Paragraph I, Section 3 of this Ordinance shall be meted out an administrative fine in the amount of Five Thousand Pesos (P5,000.00), and imprisonment for a period of one (1) year subject to the discretion of the court. Penalty includes the destruction/demolition of mini-dams, water tanks and similar structures and confiscation of the materials used, including the extracted gold and other minerals.
- 5.3 Any person found to be acting as financier, whether directly or indirectly, or as a buyer of the extracted gold or other minerals through placer mining method shall be subject to fines and/or imprisonment prescribed in Section 5.2 hereof.
- 5.4 In addition to the penalties imposed in subsections 5.1, 5.2 and 5.3 hereof, all violators shall be required to reforest the affected area and declogged all the affected waterways nearby at their own cost.

SECTION 6. PAYMENT OF FINES AND DISPOSAL OF CONFISCATED /ITEMS/MATERIALS - Fines shall be paid directly to the concerned Municipal/City Treasurer's Office while the confiscated items/materials shall become a property of the concerned barangay. **SECTION 7. REPEALING CLAUSE -** All local ordinances, resolutions, circulars and memorandums inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. SEPARABILITY CLAUSE - The provisions of this Ordinance are hereby declared to be separable, and in the event, one or more of its provisions are held unconstitutional, the validity of the other provisions shall not be affected thereby.

SECTION 9. EFFECTIVITY - This ordinance shall take effect upon approval.
