TITLE - This Ordinance shall be known as an Ordinance Providing Educational Materials Assistance for Elementary and Secondary Levels Pupils/Students in All Public Schools Located Within the Fifth Class Municipalities in the Province of Agusan del Norte and Appropriating Funds Thereof. " SECTION 2. DECLARATION OF POLICY - It is hereby declared to be the policy of the Provincial Government of Agusan del Norte to provide social services for the welfare of its constituents such as educational material assistance which shall primarily benefit the children of low-income families. SECTION 3. DECLARATION OF OBJECTIVES - This Ordinance is formulated to attain the following objectives: 1. Encourage and raise the level of awareness of the province's schoolchildren on the importance of having an education regardless of their socio-economic status in life; PCENIZA Lessen the burden of parents from low-income families in sending their childnen to school; and 3. Extend assistance to children who belong to low-income brackets by providing them with educational materials. SECTION 4. AVAILMENT OF EDUCATIONAL MATERIAL ASSISTANCE - all pupils and students enrolled in all public schools located within the 5th class municipality/ties in the Province of Agusan del Norte shall avail of the educational material assistance provided by the Provincial Government of Agusan del Norte.

SECTION 5. CREATION OF SCREENING COMMITTEE AND ITS COMPOSITION -- Immediately upon the approval of this Ordinance, the Provincial Governor shall create a Screening Committee, whose functions shall be responsible in the distribution of the educational materials to the respective beneficiaries, as well as the identification of such educational materials to be granted to the pupils and students.

**SECTION 6. FUNDING APPROPRIATION** – The Provincial Government shall appropriate the amount of Five Hundred Thousand Pesos (P500,000.00) from Non-Office Appropriation under the General Fund, starting Calendar Year 2011 and every year thereafter, as initial funding of the said program.

**SECTION 7. REPEALING CLAUSE** – Any provincial ordinance inconsistent with this legislative measure is deemed repealed, amended or modified accordingly.

**SECTION 8. EFFECTIVITY** –This Ordinance shall take effect immediately upon its approval.
