PROVINCIAL ORDINANCE NO. 277-2010

AN ORDINANCE ABOLISHING THE POSITIONS OF ADMINISTRATIVE OFFICER IV AND RECORDS OFFICER I IN THE SANGGUNIANG PANLALAWIGAN OFFICE, AGUSAN DEL NORTE

BE IT ORDAINED, by the 15th Sangguniang Panlalawigan of Agusan del Norte, in a session assembled, that:

SECTION 1. TITLE – This Ordinance shall be known as “An Ordinance Abolishing the Positions of Administrative Officer IV and Records Officer I in the Sangguniang Panlalawigan Office, this Province.”
