PROVINCIAL ORDINANCE NO. 187-2006 January 30, 2006 Page two –

> "SECTION 124-A. SURCHARGES AND PENALTIES ON UNPAID TAXES, FEES, OR CHARGES - There shall be imposed a surcharge of twenty-five percent (25%) of the amount of taxes, fees, or charges not paid on time and an interest of two percent (2%) per month of the unpaid taxes, fees or charges including surcharges, until such amount is fully paid but in no case shall the total interest on the unpaid amount or portion thereof exceed thirtysix (36) months."

SECTION 3. EFFECTIVITY - This ordinance shall take effect upon approval.

Voting of the ordinance was unanimous.
