

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, THAT -

SECTION I. TITLE - There is hereby enacted an ordinance which shall be known as "AN ORDINANCE REQUIRING BUSINESS ESTABLISHMENTS WITHIN THE PROVINCE OF AGUSAN DEL NORTE TO SUBMIT A MONTHLY JOB VACANCY REPORT (JVR) TO THE PROVINCIAL GOVERNMENT OF AGUSAN DEL NORTE AND FOR OTHER PURPOSES".

SECTION II. DECLARATION OF POLICY – It is hereby declared to be the policy of the provincial government to provide basic services, as well as employment opportunities to the constituents of the province of Agusan del Norte.

SECTION III. COVERAGE – This ordinance shall apply to all business establishments located within the territorial jurisdiction of the province of Agusan del Norte, including, but not limited to, wood manufacturing establishments; electricity, gas, and water; agricultural manufacturing; construction; internet café; financial, insurance, and real estate; food and beverage; hotels and resorts; mining and quarrying; art and sign; upholstery; transportation.

SECTION IV. REQUIREMENT - All business establishments located within the territorial jurisdiction of the province of Agusan del Norte shall submit a Monthly Job Vacancy Report (JVR) to the provincial government of Agusan del Norte through the Provincial Employment Services Office (PESO)

SECTION V. SANCTION – Any business establishment which fails to adhere to this ordinance shall be fined One Thousand Pesos (P1,000.00) for the first offense; One Thousand Five Hundred Pesos (P1,500.00) for the second offense; and Two Thousand Pesos (P2,000.00) for the third and succeeding offenses.
