**AN ORDINANCE REQUIRING BUSINESS ESTABLISHMENTS WITHIN THE PROVINCE OF AGUSAN DEL NORTE TO SUBMIT A MONTHLY JOB VACANCY REPORT (JVR) TO THE PROVINCIAL GOVERNMENT OF AGUSAN DEL NORTE AND FOR OTHER PURPOSES**

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, THAT -

**SECTION I. TITLE** - There is hereby enacted an ordinance which shall be known as "AN ORDINANCE REQUIRING BUSINESS ESTABLISHMENTS WITHIN THE PROVINCE OF AGUSAN DEL NORTE TO SUBMIT A MONTHLY JOB VACANCY REPORT (JVR) TO THE PROVINCIAL GOVERNMENT OF AGUSAN DEL NORTE AND FOR OTHER PURPOSES".

**SECTION II. DECLARATION OF POLICY** - It is hereby declared to be the policy of the provincial government to provide basic services, as well as employment opportunities to the constituents of the province of Agusan del Norte.

**SECTION III. COVERAGE** - This ordinance shall apply to all business establishments located within the territorial jurisdiction of the province of Agusan del Norte, including, but not limited to, wood manufacturing establishments; electricity, gas, and water; agricultural manufacturing; construction; internet café; financial, insurance, and real estate; food and beverage; hotels and resorts; mining and quarrying; art and sign; upholstery; transportation.

**SECTION IV. REQUIREMENT** - All business establishments located within the territorial jurisdiction of the province of Agusan del Norte shall submit a Monthly Job Vacancy Report (JVR) to the provincial government of Agusan del Norte through the Provincial Employment Services Office (PESO). ✓

**SECTION V. SANCTION** - Any business establishment which fails to adhere to this ordinance shall be fined One Thousand Pesos (P1,000.00) for the first offense; One Thousand Five Hundred Pesos (P1,500.00) for the second offense; and Two Thousand Pesos (P2,000.00) for the third and succeeding offenses.



**SECTION VI. EFFECTIVITY** – This ordinance shall take effect upon approval.


