AN ORDINANCE ADOPTED BY THE SANGGUNIANG PANLALAWIGAN OF AGUSAN DEL NORTE, IN ITS 24TH REGULAR SESSION HELD AT THE SP SESSION HALL, PROVINCIAL CAPITOL COMPOUND, BUTUAN CITY ON JANUARY 17, 2005.

PROVINCIAL ORDINANCE NO. 165-2005

AN ORDINANCE MANDATING THE GENERAL SERVICES OFFICE TO HAVE POSESSION, CUSTODY AND CARE OF ALL COPIES OF DOCUMENTS SUCH AS LAND TITLES, CONTRACTS, AGREEMENTS, LICENSES AND THE LIKES INVOLVING THE PROVINCE OF AGUSAN DEL NORTE

EXPLANATORY NOTE

WHEREAS, time and again, it has been the sad experience of the Sangguniang Panlalawigan of Agusan del Norte when confronted with problems such as real property claims, boundary disputes, renewal of contracts, agreements or licenses and there is a need to retrieve the corresponding document but the same cannot be found;

WHEREAS, the difficult retrieval of these very important documents put the Provincial Government in a disadvantage position in cases where the production of these documents are vital in enforcing and protecting the province's proprietary rights;

WHEREAS, the problem can be remedied by assigning a particular office that will serve as official repository of all kinds of documents where the province is involved or a signatory thereof.

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. The General Services Office is mandated to have possession, custody and care of all copies of documents such as land titles, contracts, agreements, licenses and the like involving the province of Agusan del Norte.

SECTION 2. The General Services Office shall likewise implement a system of easy retrieval taking into consideration the classification of documents and to make them available anytime to the proper authorities whenever necessary.

SECTION 3. This ordinance shall take effect upon its approval.

Voting of this ordinance was unanimous.
