WHEREAS, the study entitled: "Streamlining the Provincial Bureaucracy" conducted by the Provincial Streamlining Task Force last August 2003" concluded that the number of decreasing warm bodies does not affect performance of the province's primary goal to deliver basic services to our constituents;

WHEREAS, performance level of the province as shown in the assessment on Local Performance Measurement System conducted by the Department of Interior and Local Government (DILG)-Agusan del Norte for the period 2000-2002, increased from 81.36% in 2001, 85.69% in 2002 and 88.42% in 2003, notwithstanding the decrease in manpower warm bodies;

WHEREAS, the Local Government Code of 1991 provides that the "chief executive shall be responsible for human resources and development";

WHEREAS, in view of the aforementioned premises, this Body hereby abolishes the positions of the provincial government which have been left vacant for more than three (3) years since their being unoccupied does not affect the performance of the province.

NOW THEREFORE-

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, to -

SECTION 1. TITLE - This ordinance shall be known as "An Ordinance Abolishing Vacant Positions of the Different Offices of the Provincial Government of Agusan del Norte".

SECTION 2. POSITIONS TO BE ABOLISHED: The following positions under the different offices of the Provincial Government of Agusan del Norte with their respective office, item number and annual rate, shall hereby be abolished, to wit:



SECTION 5. EFFECTIVITY – This ordinance shall take effect upon approval.






