AN ORDINANCE ADOPTED BY THE SANGGUNIANG PANLALAWIGAN OF AGUSAN DEL NORTE, IN ITS 28TH REGULAR SESSION HELD AT THE SP SESSION HALL, PROVINCIAL CAPITOL COMPOUND, BUTUAN CITY ON FEBRUARY 14, 2005.

PROVINCIAL ORDINANCE NO. 167-2005

AN ORDINANCE CREATING A MONITORING TEAM OF THE PROVINCE OF AGUSAN DEL NORTE TO OVERSEE AND MONITOR ANY INCOMING COCONUT AND OIL PALM PLANTING SPECIES TO PREVENT CADANG-CADANG OUTBREAK IN THE REGION

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, that:

SECTION 1. TITLE- There shall hereby created a Monitoring Team of the province of Agusan del Norte to oversee and monitor any incoming Coconut and Oil Palm Planting Species to prevent Cadang-Cadang outbreak in the region.

SECTION 2. DECLARATION OF POLICY.- It is hereby declared the policy of the province of Agusan del Norte that all agricultural products and industries of the province shall be protected and free from any injurious plant pests and diseases existing in other cities provinces regions and even foreign countries, as well as to regulate the domestic movement of plant materials in order to minimize the spread of such existing injurious plant diseases.

SECTION 3. - COMPOSITION - To effectively monitor and prevent the possible entry of Cadang-Cadang disease and other injurious plant diseases composition of team is hereby created:

Page two -

2. Report to the Plant Quarantine Offices the presence of anything under No. 1 of letter A of the functions;
 3. Assist the Plant Quarantine Officer in the event disposal of confiscated Coconuts to include among others as enumerated in Section 7 of BPI AO No. 13, s, of 2004;
- B. To withhold any coconut and "others" as enumerated in Section 7 of BPI AO No. 13, s of 2004 intercepted along the coastline of Agusan del Norte thru any mode of vessel and to report immediately to the nearest station of the Plant Quarantine Office.
- C. Information dissemination:
1. Assist/make reading materials like posters, brochures, slogan
 2. Coordinate mass media for TV and radio broadcast
 3. Conduct/Assist technical briefing to technologist and information drive to farmers.

SECTION 5. MEETINGS - There shall be a regular monthly meeting to be conducted by the Monitoring Team to ensure the sustainability of the implementation of this ordinance.

SECTION 6. FUNDING ASSISTANCE-The operational expense of the Monitoring Team shall be charged in the account of the Provincial Agriculturist Office.

SECTION 7. EFFECTIVITY - This Ordinance shall take effect upon approval.

Voting of this ordinance was unanimous.
