AN ORDINANCE ADOPTED BY THE SANGGUNIANG PANLALAWIGAN OF AGUSAN DEL NORTE, IN ITS 139TH REGULAR SESSION HELD AT THE SP SESSION HALL, PROVINCIAL CAPITOL COMPOUND, BUTUAN CITY ON JUNE 29, 2001

PROVINCIAL ORDINANCE NO. 110-2001

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 093-2000 ENTITLED "AN ORDINANCE OUTLAWING EMBALMING HELD IN PLACES OTHER THAN INSIDE DULY LICENSED FUNERAL HOMES WITHIN THE PROVINCE OF AGUSAN DEL NORTE"

BE IT ORDAINED, by the Sangguniang Panlalawigan of Agusan del Norte in session assembled, that:

SECTION 1. The title of Provincial Ordinance No. 093-2000 is hereby amended to read as follows:

"An Ordinance Outlawing the Disposal of Parts and Visceral Organs of the Human Cadaver in the premises of Residential Homes within the Province of Agusan del Norte".

SECTION 2. Section 1 of Provincial Ordinance No. 093-2000 is amended as follows:

"Section 1. In case embalming is conducted in a residential home, no parts or visceral organs from the body of the deceased or cadaver shall be disposed anywhere except inside a duly licensed funeral home and that a licensed embalmer shall perform said embalming. All rules and regulations promulgated by the Department of Health and any ordinance of the Local Government Unit shall be strictly followed therein".

SECTION 3. Section 4.a. is hereby amended as follows:

"Section 4.a. Any persons who actually disposes parts or visceral organs of human cadaver in places other than the funeral homes shall be meted an imprisonment of from four (4) months to eight (8) months and/or a fine of from Two Thousand Pesos (P 2,000.00) to Three Thousand Pesos (P 3,000.00);"
