"AN ORDINANCE CREATING THE EQUIVALENT POSITIONS OF DEVOLVED PERSONNEL FROM THE DEPARTMENT OF HEALTH, AGUSAN DEL NORTE AND FOR OTHER PURPOSES."

"BE IT ORDAINED by the Sangguniang Panlalawigan in session assembled:

SECTION 1. Title - The ordinance shall be known as an Ordinance Creating the Equivalent Positions of devolved personnel from the Department of Health, Agusan del Norte and for other purposes.

SECTION 2. Scope/Coverage - This ordinance shall cover all positions of the Department of Health devolved in the Provincial Government of Agusan del Norte, subject to the applicable provisions of Executive Order No. 503 and Executive Order No. 507 of the Office of the President.

SECTION 3. Creation - There is hereby created/transferred the positions of the Department of Health reflected in its plantilla of personnel to the Provincial Government of Agusan del Norte.
